Cancellation Policy with Terms and Conditions:

- In current pandemic situation, we request all guests to abide by the mandatory requirements for travel to the destination, such as RT-PCR tests, web check-in, self-declaration, e-pass formalities etc. as per the state/country, which are subject to change periodically. Any cost incurred for such requirements should be borne by the guests. Given the current dynamic situation some monuments or sightseeing places may be closed temporarily without any prior notice; in such cases every attempt will be made to visit an alternate sightseeing if possible.
- If the trip is cancelled due to increase in pandemic situation OR natural calamities, then trip cost will not be refunded but forwarded in the next same itinerary trip. In such case any transport cancellation in railway/ flight

- if happened then such loss should be borne by guests. Even if any cancellation happened from railway/flight side then PRATHAMESH TOURS is not responsible for any cancellation done by railway/flight.
- Cheque payments shall be done in favor of "**PRATHAMESH TOURS**" payable at Mumbai. Customer can book the tour with 50 % advance of the tour cost. Remaining balance has to be paid 45 days prior to the date of departure.
- Tour Cost does not include Air / Rail fare. Tickets booking is not our business. We book tickets on behalf of our customers. It is a free service provided by us to those who travel with us.
- In case of fluctuations in fare of Bus / Railway / Air fares, the same shall be borne by the customers at an additional cost. (Some tour cost includes Flight tkt. amt.)
- In computerized reservation system of railway, the berths / seats once reserved cannot be changed. Tour participants will have to travel by the same berths / seats as mentioned in the ticket issued by Railway. It is Automatic number system.
- Baggage & personal valuable belongings of the tour participant are his / her responsibility. The company shall not be liable for the loss / damage of the same.

- In the event of natural calamities or unavoidable circumstances which are beyond the companies control, management or tour manager has the right to change, amend, modify the tour plan / route or cancel the tour. The decision of the Tour manager / management will be binding to all. The additional cost for such alteration / loss will be borne by the participant. If tour cancelled due to natural calamities, then deposited amt. will be adjusted against the same subject tour in the future. No refund will be compensated & customer has to be adjusted his time & date for upcoming tour.
- PRATHAMESH TOURS reserves the right to alter, amend, postpone, or cancel any of the tours advertised in the Brochure, Website without assigning any reason, whatsoever. Under such circumstances of cancellation of any

tour by the company, money paid by the participant will be fully refunded, but no compensation or interest is payable.

• If the tour participant misbehaves causing inconvenience or annoyance to any tour participant or cause damage to the property of the company, he/she will be asked to leave

the tour immediately. The tour manager has been authorized to do so. There will not be any compensation, whatsoever, in such cases.

Cancellation Policy:

- Company always make advance booking of Hotels, transportation & other arrangements for our esteemed customers, If the Guest decides to cancel the tour for any reason whatsoever then he / she shall give a written application to the Company within specified time limit along with original receipt issued by the Company. Such cancellation will attract cancellation charges stated hereunder.
- Cancellation charges will be calculated on final tour cost and the cancellation charges shall depend on date of departure and date of cancellation.
- Cancellation charges for any type of transport ticket are applicable as per the rules of the concerned authority.
- Air tickets issued on special fares are NON REFUNDABLE and Guest shall bear full ticket cancellation charges.
- Any refund payable to the Guest will be paid after the Company receives refund from the respective authorities. The Company deducts processing charges from the refund to be paid to the Guest.
- Any disputes arising in respect of the tour shall be subject to Mumbai jurisdiction.

Air Line Policy:

- Check-in starts "2 hours" before scheduled departure, and closes 45 minutes prior to the scheduled departure time. Passengers are requested to report at least 2 hours prior to departure time, at airline Check-in counters.
- One piece of cabin baggage of maximum 7 Kg (maximum 115 cm (L+W+H) in overall dimensions on Boeing flights and 50cm+35cm+23cm (Total 108cm) on Bombardier flights) is allowed per passenger. Passengers with infants are allowed an additional piece of hand baggage of maximum 7 Kg not exceeding the size to dimensions. Due to airport security regulations, no cabin baggage is allowed on flights originating from Jammu or Srinagar airports.
- Airline allows free checked baggage allowance of 15 kgs not to exceed 158 cm in overall dimensions (L+W+H), per passenger for all domestic bookings. High season surcharge as per the rules of the Airline concerned has to be paid by the Tourist. Airline is an independent vendor and the company does not have any control on their operations, neither on the increase in air fare, fuel nor any other taxes. Any increase in airfare, airport taxes, fuel surcharges after the booking/registration will have to be paid and borne by the tourist. Air Ticket Cancellation charges plus deposit forfeit charges as are applicable under the rules of the concerned Airline are to be paid by tourist immediately in the event of cancellation of the tour by tourist.

Photo identification:

All tourists travelling by air for Indian / domestic sectors are advised to carry the photo identification in the form of driving licence, election ID card, Aadhar Card, Pan card and for students their school / college ID card. At certain sightseeing places, the Identification proof is required for which company has no control and is mandatory. The identification documents must be produced by the tourists as per the rules and regulations prescribed at different locations.
